

## Micheville-Villerupt LF5422 : private airfield, landing request form (PPR)

From the bye-law established by the prefecture 22/10/1993 (translation)

*The use of airfield LF5422 is restricted to the members of the aeroclub « REV espace loisirs ». A list of these pilots names must be given to the sub-prefecture every year.*

*Due to the specifics of the airfield environment, all users must ensure that:*

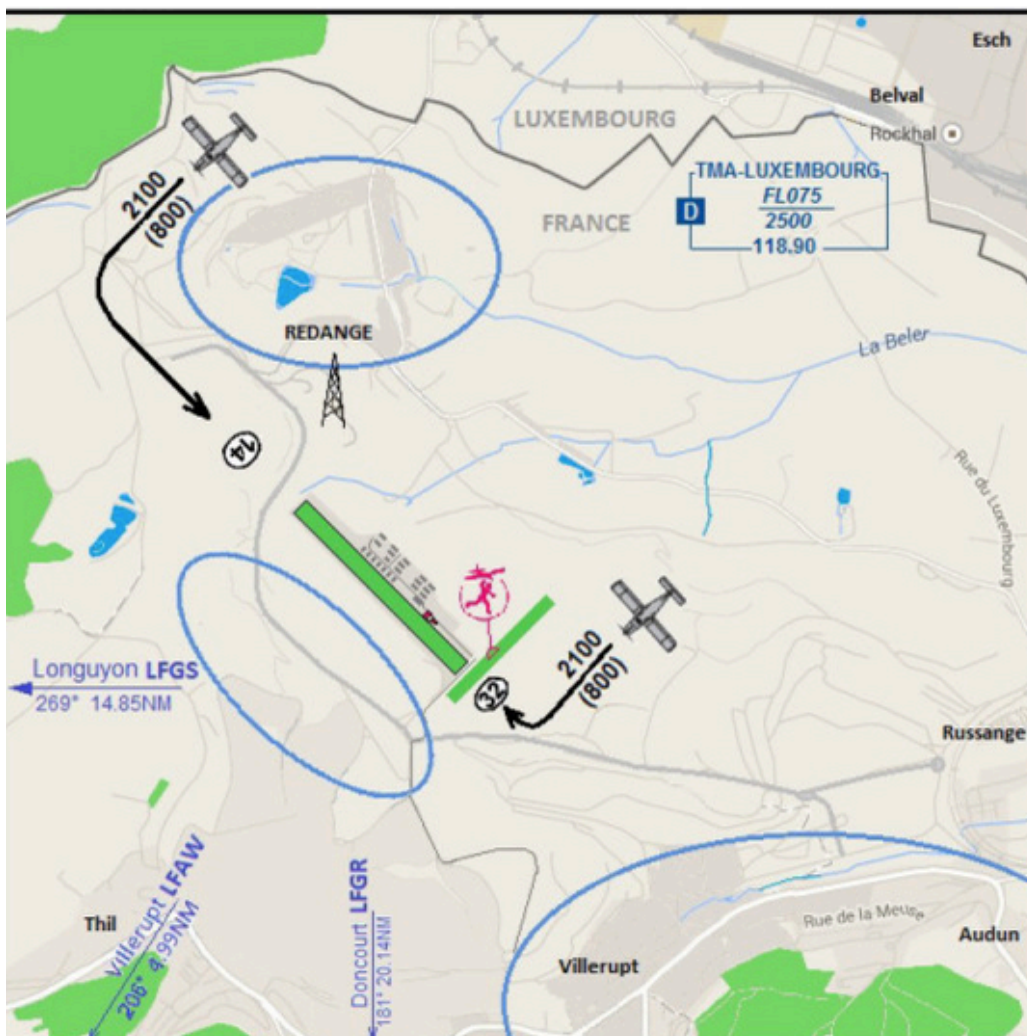
- the take-off and landing performance of their aircraft ;
- the state of the runway ;
- the wind conditions ;

*permit the use of the facility in satisfactory conditions of safety.*

Traffic circuit is to the North at 1000 ft AAL avoiding the overflight of villages and towns, and staying below 2 500 ft (lowest level of Luxembourg-Findel TMA)

Runway 14-32 : length 800 m by 40 m, rising by 2% towards NE
